## President's Message

### **The Landscape Architecture Foundation of Canada (LACF)**

Founded in 1988, the LACF was founded thanks to the initiative and financial support of the CSLA College of Fellows. The Foundation is a not-for-profit and charitable organization and can therefore issue receipts for tax purposes in Canada. A significant first donation from the estate Frances Macleod Blue allowed the organization to establish itself financially and begin working on the foundation's pillars of supporting research, education and communication in landscape architecture in Canada. For the first time in its history, the Foundation has assets of approximately \$1Million.

### **Overview of 2019**

To take advantage of the synergy of the CSLA Congress, the Foundation holds its Annual Membership Meeting and Annual Board Meeting at the same time as the CSLA Congress, held in Vancouver in 2019. At the closing gala of the Congress, and thanks to the collaboration of the CSLA, Peter Briggs, former president of the CSLA, appealed to the generosity of those present to support the Foundation. The answer was, as always, and even more than usual, a resounding success.

Inspired by the moment and in pursuit of the theme of the Congress (Reconciliation), Chris Grosset launched a challenge, wishing to establish a Scholarship for a First Nations person in Canada. Not only was the goal achieved but exceeded! This 15th scholarship is in addition to the existing ones and will thus allow us to deliver more programs in line with our mission. ## Mot du président

### **La Fondation d'architecture de paysage du Canada (FAPC)**

Fondée en 1988 la FAPC a vu le jour grâce à l'initiative et le support financier du Collège des Fellows de l'AAPC. La Fondation est un organisme à but non lucratif et de bienfaisance, et peut donc dispensés des reçus pour fins d'impôts au Canada. Un premier don significatif de la succession Frances Macleod Blue a permis à l'organisme de s'établir financièrement et de commencer à travailler sur les piliers de la fondation qui consistent à supporter la recherche, l'éducation et la communication en Architecture de Paysage au Canada. Pour la première fois de son histoire la Fondation affiche des actifs d'environ 1 Million \$.

### **Survol des activités de 2019**

Afin de profiter de la synergie du Congrès de l'AAPC, la Fondation tient sa réunion annuelle des membres et sa réunion du conseil annuelle en même temps que le congrès de l'AAPC, qui en 2019 se tenait à Vancouver. Lors du Gala de clôture du Congrès, et grâce à la complicité de l'AAPC, Peter Briggs, ancien président de l'AAPC, a fait appel à la générosité des personnes présentes afin d'apporter leur appui à la Fondation. La réponse fut comme toujours, et même plus que d'habitude, un succès retentissant.

Sous l'inspiration du moment et en poursuite du thème du congrès (Réconciliation), Chris Grosset a lancé un défi, souhaitant établir une Bourse d'étude d'étude pour un membre des Premières Nations du Canada. Non seulement l'objectif fut atteint mais dépassé! Cette 15ième bourse s'ajoute à celles existantes et permettra ainsi de livrer plus de

Last September, the Board met in Winnipeg for a weekend of reflection and planning on the future of the Foundation. Thanks to the support of a facilitator, the two days were devoted to reflecting on our achievements, the structure and organization of the foundation and more importantly to look towards the future. Through well-prepared workshops, members actively contributed, participated and a new roadmap was set for the next 5 years. One of the most important conclusions was to enlist the help of a person who could assume the permanent direction of the foundation even if on a partial basis. In a way victim of our successes, the Foundation has made great progress in recent years and in order to maintain, and hope to exceed this progress, these achievements require us to now to establish an operational base that is not entirely the responsibility of the volunteers of the members of the Board. This is how the LACF and the CSLA entered into a service agreement where Ms. Michelle Legault will act as Executive Director of the Foundation. It is clear that the 2 organizations are independent, but it is also clear that we also share many commonalities and that the expertise that Michelle has brought to the CSLA will also benefit the Foundation. We are confident that this symbiosis will benefit both organizations and potentially the people they serve. The agreement will begin in January 2020 and will be reviewed and adjusted at the end of the first year.

## Objectives for 2020

## Dispossession by Design: Recovering The Role of Landscape Architects in the Early Colonial History of National Parks in Canada

*Tiffany Kaewen Dang, PhD Candidate, University of Cambridge, UK*

*Recipient of the Gunter Schoch Bursary*

*Grant: \$6,000*

National Parks hold iconic significance in the Canadian imagination as the proverbial ‘natural jewels’ of the nation. However, behind these important landscapes lies a dark history of colonization, beginning with the establishment of Banff National Park in 1885 and the subsequent displacement of the Stoney Nakoda First Nation. For over a century, the Canadian national parks system has been utilized as an instrument for colonizing the so-called ‘frontier,’ promoting through tourism and conservation, an imaginary vision of untamed wilderness; thereby implementing a policy of Indigenous erasure and cultural domination.

## The Reparative Logics of World War II Confinement Camp Preservation: British Columbia, Alaska and Hawai‘i in Context

*Grant \$5,000*

April 2017, the British Columbia Register of Historic Places recognized more than 56 sites, buildings, and landscapes as part of the Provincial Recognition Program’s Japanese-Canadian Historic Places Project to promote the study, management, preservation, and interpretation of these sites and their associated culture aspects. Included in the recognition are World War II internment camps, self-supporting sites, and road camps, in addition to fishing, mining, and logging communities that confined Japanese-Canadians from 1942-1949. The PhD dissertation aims to uncover the role of landscape/ruins/ material traces in the larger project of government recognition and redress for historical injustices.

## Developing a manual and framework for iterative place-making in Canada's North

Canada's northern communities are changing fast. Climate change will lead to numerous social, economic, and infrastructure changes, including melting permafrost; possibility for food production; increased populations, shared wealth, and tourism; and a shifting sense of place, traditions, and connection to the land for Indigenous people. In addition, expanded natural resource exploration, tourism, and a history of "building wherever possible" has led to seasonal and temporary population booms, exacerbating social barriers, and undemocratic decisions in these communities.

## Memory, Place & Change on the Tantramar Marshes

The Tantramar Marshes, located at the heart of the maritime provinces of Canada, is a landscape layered in cultural and natural significance. As one of the largest contiguous salt marsh ecosystems on the east coast of North America, it possesses a stunning diversity of ecological services. A rich cultural history parallels its ecological value, a past that tells the story of Canadian history, writ large across its fields, rivers, dykes, through architectural and landscape artifacts.

## Urban Abundance: Alternative Future Landscape Scenarios to Increase Urban Food Security and Optimize Ecological Integrity in Ottawa, Canada

Urban agriculture, defined as the cultivation, processing and distribution of crop and livestock goods within cities and towns, is widely regarded as an important strategy to enhance urban food security. Urban agriculture is associated with both positive and negative environmental impacts. The research indicates that landscape ecology and the spatial pattern of land uses, agriculture included, has critical ecological implications.

## Past Grant Accomplishments

Two of the projects funded by the Annual Grants program would have been presented at the June 2020 Congress in Calgary. Unfortunately, due to the cancellation of the conference, neither project is being highlighted in the manner anticipated:

The Canadian Landscape Portfolio Initiative by Jean Laundry was to have a Speaker's Panel composed of 3 or 4 presentations for integration within an Ebook that was partially funded by the LACF grants program. The e-book was originally scheduled to be produced by the end of 2020; now it will be produced during the winter of 2021. There will be some kind of 2020 event for the AALA-CSLA. The Panel and the Ebook project will be part of the June 2020 CSLA AGM.

The Literature Review by Emily Thorpe was the foundation for the design by Virginia Burt Designs of Morgan's Garden. Morgan's Garden won an Ohio Chapter ASLA award in research and communication. Virginia Burt and Emily Thorpe research for this garden for Adults with Autism and it is likely the first of its kind for such a day program. Virginia was to present this work during the June 2020 CSLA Congress.

### Administration:

In April 2018, a revised terms of reference for the Grants Committee was adopted by the LACF Board. Policies for the Gunter Schoch Bursary, Donald Graham Bursary and Northern Research Fund were updated and approved by the Board. The Grants Committee has been working on updating the policy for the Special Project Grants.

### Grants Process:

The 2019 grants were awarded in early January. The progress made by the grant recipients is monitored during the year. Grants from prior years are brought to completion. At this point in time there are two outstanding grants from 2019 to be completed by December 2020.

The Grants Committee also reviews and updates the grants application. The LA schools, CSLA and past recipients are notified of the grants due date and submission requirements in early fall. The Grants Committee confirms jury membership and notifies the Board. Grant applications are received in November and distributed to the jury with comments/recommendations requested for mid-December. The consensus of the jury and funding recommendations are finalized for early January.

## Communications Committee Report

The following report, for information and record, relates LACF Communication Committee (CC) activities in 2019. It was a busy year.

The LACF website content and design was refreshed during the early months of 2019 in collaboration with Luna Design and under the supervision of CC chair Wendy Graham with assistance from many members of the board. The site conserves a Drupal software platform. Updated content and graphic layout better reflect the LACF mission to support research, communication and scholarship and now features our people, scholars, sponsors and supporters more prominently. The new site was launched in May coinciding with the CSLA Congress and was well received. French translations for the entire site were completed online in December. The site is now bilingual, easier to navigate, features a more engaging landing page and continues to integrate our monthly bulletin via the Newsroom.

This year the communication committee welcomed four new members including Jill Robertson, Bob Somers, Christine Abe and Ed Versteeg. The committee developed and tabled a CC TOR document, discussed and began implementing a social media action plan (Instagram and Linked in), outlined a preliminary Liaison strategy to broaden outreach, collaborated with the Fundraising Committee on the 2020 Call for Sponsors, contributed content for LACF bulletins and press releases, produced an annual calendar of activities, maintained and updated website and set up a Board Only portal in collaboration with Governance Committee. Thank you to all committee members and collaborators for enthusiastic input, ideas and actions.

The 3 day Winnipeg Strategic Planning session (Sept 2019) provoked 2 significant outcomes for the CC:

1. The Board agreed in principle that the operational dimension of communications would be delegated to an executive director (or equivalent) to improve the human resource capacity of the board and LACF to sustain its mandate and enhance its impact.
2. Strategic session discussions revealed that LACF would benefit from a review of LACF's communication message (vision, mission and values) to better reflect the work we do today and why we do it. The Committee worked on this challenging task in collaboration with Judy Lord (past LP editor and writer) and a preliminary document was tabled at the 2019 December board meeting for comment. A revised version is to be tabled in June 2020 at the AGM for further review.

In closing, it has been an honor to act as the Communication Committee Chair since 2014. I am proud of where we are today and hopeful about where we are going tomorrow. Thank you all for your assistance and collaboration over the years.

## 2019 LACF Scholarship Committee Report

LACF awarded 14 scholarships worth \$17,000 in 2019. New scholarships given for the first time this year include the Canadian Landscape Charter Scholarship, initiated by Professor Mary-Ellen Tyler at the University of Calgary and the Alain Lamontagne Scholarship, endowed by the office of Durante Kreuk at the University of Guelph (BLA). Also introduced in 2019 was the Bourse d'études Danielle Routaboule du voyage, an award endowed by University of Montreal professor, Danielle Routaboule, to support student research and travel. Other scholarships include the Robillard Scholarship at the University of British Columbia and those formerly known as the Andre Schwabenbauer Awards, which have been re-named to reflect regional and corporate donations that resulted in permanent endowment of these scholarships. Scholarships at the University of Montreal and Northern Alberta Institute of Technology remain named in honour of Andre Schwabenbauer, in recognition of his personal connection to these two programs. In addition to scholarships initiated by LACF, the SALA Academic Award and APALA's Peter Klynstra Memorial Scholarship, are administered through their respective component associations with fund management by LACF.

Recipients of LACF scholarships and awards in 2019 include: Kendra Cheeseman, Selena DeWolf, Amelie Fortin, Tan Au Ca Nyugen, Michael Wideman, Grace Christie, Beth Bray, Nicole Reenders, Mengyi Zhang, Christina Peace, Kathryn McCudden, Thu Ngo, Mason Lam, and Karen Tomkins. Significant attention was given this past year to establishing the Frederick Gage Todd National Scholarship, which is anticipated to be awarded for the first time in 2021. Unlike other LACF scholarships, a jury of professionals will review and evaluate student submissions and recommend a winner. Professors Cynthia Girling, Nicole Valois and Robert Corry provided guidance in the development of this scholarship, intended to serve as the Foundation's premier student award. A second national award, the National Indigenous Scholarship, is being co-sponsored by Indspire. This award will be directed to indigenous students attending accredited programs in Canada. The CSLA's Reconciliation Advisory Committee was led the development of this scholarship.

Members of the Scholarship Committee include Jill Robertson, Ed Versteeg and Cecelia Paine (Chair). The committee wishes to thank Judy Bennett from Durante Kreuk, who was instrumental in administering the 2019 LACF scholarship program.

## Industry

- Many if not most industry sponsors are sitting a bit on the sidelines at the moment. They are trying to catch up on a backlog of orders delayed by the pandemic lockdown and looking at a great deal of uncertainty moving forward.
- Fortunately, several of our major sponsors including Maglin and Landscape Forms made their contributions in December.
- A donation plea has been sent out to all previous sponsors and to the list we have developed.
- Industry sponsorships to date are \$36K. (Maglin \$25K, Landscape Forms \$10K, Aco \$1K)
- An industry ASK will be sent out in the coming days.
- The emailed ASK will be followed up with personal phone calls.

## Landscape Architectural Firms

- We are developing a strategy to target Canadian Landscape Architectural firms specifically.
- Local / Regional champions will make direct contact with firm principals.
- An email to most Canadian landscape architectural firms will be sent out in the coming weeks.
- The emailed ASK will be followed up with personal phone calls made by regional champions

## CSLA Fellows

- We are working with the Executive of The COF to develop the best way to encourage them to contribute more generously this year.

## Landscape Architects

- Given the fundraising challenges due to the cancellation of the 2020 Congress in Calgary, we are sending out a targeted pleas to Landscape Architects who typically attend the congress, those who have traditionally donated at the Congress – primarily at the Gala auction, and to the general CSLA membership to make up the projected shortfall.
- Personal contact by regional champions will follow up on the email plea.
